RESOLUTION 1A-2023 RESOLUTION REQUESTING CERTIFICATION OF ALTERNATIVE TAX RATES FOR AN INCOME TAX

WHEREAS, Ohio Revised Code ("Revised Code") Section 5748.02 authorizes school districts to impose voter-approved income taxes upon their residents; and

WHEREAS, a resolution declaring the necessity to raise School District revenue must be passed and certified to the Tax Commissioner for the State of Ohio (the "Tax Commissioner") in order to permit the Board to consider the levy of an income tax and to preserve the right to submit the question of levying such an income tax to the electors of the entire territory of the School District at the election to be held November 8, 2022;

NOW, THEREFORE, BE IT RESOLVED by the Board of Education of the Blanchester Local School District, Clinton County, Ohio, a majority of the members of the Board concurring, that:

The Board determines that it is necessary to pursue an income tax (the "Income Tax") to raise annually the sum of \$2,186,617 for the purpose of providing for current expenses

and permanent improvements for the School District for a period of six years.

The income that shall be subject to the Income Tax is the taxable income of individuals as defined in Revised Code Section 5748.01(E)(1)(b).

The Treasurer is directed to immediately certify a copy of this Resolution to the Tax Commissioner, not later than July 29, 2022, together with a request that the Tax Commissioner determine and certify to the Board the property tax rate that would have had to be imposed by the School District in the current year to produce the amount of money set forth above and the income tax rate that would have had to have been in effect for the current year to produce the amount of money set forth above.

All formal actions of this Board concerning and relating to the passage of this Resolution were adopted in an open meeting of this Board, and all deliberations of this Board and of any of its committees that resulted in such formal action were in meetings open to the public in compliance with all legal requirements, including Revised Code Section 121.22.

WHEREAS: The Board of Education desires to reduce costs and at the same time maintain the highest possible educational standards, and WHEREAS: The Board of Education has determined it will need to obtain early retirements or resignations from staff in a manner which reduces salary costs for the district.

RESOLUTION 4-2023 THEREFORE BE IT RESOLVED: That the Board authorizes the Superintendent and Treasurer to negotiate retirement incentive plans and/or resignations, on its behalf, with staff members so long as such plans reduce salary costs for the District. BE IT FURTHER RESOLVED: That the Superintendent and the Treasurer have the authority to sign and authorize any documents relating to any retirement incentive plan and/or resignations they negotiate on behalf of the Board.
